A University of Connecticut student from the town of Onondaga bought alcohol for two 18-year-olds charged in the hit-and-run death of a UConn freshman, police say.

Kara Satalin, 18, of 4853 Woodbriar Drive, turned herself in at the UConn police headquarters in Storrs, Conn., just after 5 p.m. Sunday. She was charged with purchasing alcohol for a minor, conspiracy to procure liquor for a minor, misrepresentation of age to procure liquor, third-degree identity theft and conspiracy to commit third-degree identity theft, police said.

Anthony P. Alvino and UConn freshman Michele A. Hall were arrested Thursday and face several felony and misdemeanor charges.

investigators say Alvino was driving and Hall was his front-seat passenger when their sport utility vehicle struck UConn student Carlee Wines, 19, of Manalapan, N.J., in a campus crosswalk Jan. 20. Wines died at Hartford Hospital two days later.

Police said Satalin, a June graduate of West Genesee High School, was not in the vehicle.

Satalin, according to an arrest affidavit, bought three to four bottles of vodka at a liquor store Jan. 19 for Alvino, Hall and others. Satalin acquired a driver's license from Hall, who said the woman in the photo resembled Satalin, officials said.

She was released on a \$5,000 bond.
